ROLL-OFF SERVICE CONTRACT

1. CHARGES & PAYMENTS:

Charges are based on location and size of the container. The landfill fee listed below includes 3 tons or less. If the weight exceeds 3 tons, you will be billed a minimum \$36 per ton and sent a copy of the landfill ticket for your records. After each Empty and Return, you will receive a bill and payment must be received within 10 business days. Your account balance must be zero before an additional Empty & Return can be made. For your convenience, you can pay online at www.azcitysanitation.com, request a credit card authorization and fax it back to 520-466-6689, or come into our office and pay with Cash, Check, Money Order, Debit Card, Visa, or Mastercard. If your account goes past due, we may enforce our right to cancel your account, pick up our Roll-Off container leaving any trash left in it, and applying your deposit to the final bill. Any outstanding balance will be your responsibility to pay and collection action may be enforced. Below are the charges you can expect for a _____ yard Roll-Off Service in _____:

2. DEPOSIT REQUIRED:

* The deposit must be made before the Roll-Off can be delivered. The deposit will be applied to your final bill.

3. NO PULL – MINIMUM FEE:

If you do not have an "Empty & Return" every 30 days from your start date, you will be charged the base price for each Roll-Off.

4. DEAD TRIP FEE:

If you call to have our driver come out to the location and the driver is unable to take the Roll-Off Container because it is too heavy, blocked by an object, and/or told the container is not ready for pick up and needs to come back, you will be charged a dead trip fee.

5. CONTAINER:

The container is full when level with the top. Do not let anything hang over the edge (for example: boards, tree limbs, etc...). It is very important that you do not load unevenly or everything on one side, keep the weight distributed. Customer shall not overload the equipment, nor use it for incineration purposes, and shall be liable to Contractor for loss or damage in excess of reasonable wear and tear. **We have had problems in the past with concrete, tile, and/or dirt being overloaded in the container. Please fill less than halfway if putting these items in the container. We are not permitted to haul over-weight containers. Fines run into thousands of dollars. It is the customers responsible for unloading over-loaded containers.**

6. NONCONFORMING WASTE:

Waste delivered to Contractor hereunder will not contain any hazardous or toxic waste as defined by local, state, federal or provincial laws or regulations. This includes, but not limited to: tires, batteries, paint, oil, oil drums, coolers, or any type of appliances that may contain toxic or dangerous waste. If you have a questionable item, please call us at 520-466-6001 prior to putting it in the dumpster. **All fines and charges imposed on us by the City Landfill or ADEQ (Arizona Department of Environmental Quality) for clean up will be the responsibility of the customer.**

7.-CUSTOMER AGREES:

Customer shall indemnify, hold harmless and pay or reimburse A.C. Sanitation Service, LLC for any and all costs, damages and/or fines incurred as a result of putting nonconforming waste in the dumpster. Customer warrants that any right-of-way provided by Customer from Customer's equipment location to the most convenient public way is sufficient to bear the weight of all of the Contractor's equipment and vehicles reasonably required to perform the service herein contracted. Contractor shall not be responsible for damage to any private pavement or accompanying sub-surface of any route reasonably necessary to perform the services herein contracted.
